MINUTES

- 1. WELCOME** - President Linda Williams, called the meeting to order at 12:11 pm. Those in attendance, and constituting a quorum were:

- 2. SECRETARY'S REPORT** – President Linda Williams stated the position of club secretary is still open. The February meeting Secretary's Report was voted on by e-mail votes of the Board after the meeting. It is available on Google Drive.
- 3. FINANCIAL REPORT** – Treasurer, Wade Warren, was unable to attend the meeting, so Linda Williams delivered the Treasurer's Report. She presented a partial overview of the club's finances. They included \$2559.81 in the club's checking account. Linda said a clerical error resulted in a purchase to Penzeys Ltd. for \$50.62. That amount has been refunded to the account and will be reflected in the April checking account statement. The current amount in the club's checking account and Paypal accounts will be reported by Wade when he submits the full Treasurer's Report to the Board for approval by e-mail. It will be available on Google Drive.
- 4. MEMBERSHIP REPORT** – Linda helped new Membership Rep./Database Mgr., Bob Russell, by preparing the report this month. He will handle the office responsibilities going forward. Currently ZONC membership stands at 96 primary members and 14 associate members for a total of 121 current members. There are 3 new members and 11 sponsors. Linda also broke down club memberships by vehicle models and geographic areas. Linda reported there was a drop in memberships this month, possibly due to no letters being sent to current members whose membership had recently expired. Linda will send out the current notices and Bob will handle the letters going forward. It was also decided that members past due by more than 6 months will have their membership start date with the club reset to the date they renew rather than hold their original date. The Board will vote to

approve the Membership Report via e-mail after the meeting. It will be available on Google Drive.

A. **ZONC EVENTS -- Dates and Locations –**

1. **Amador County to Lodi Fun Run** – North Valley, Susan Keller, and her husband Nick Fisher are the organizers of the April 4, 2020 event.
2. **General Meetings** – Linda Williams said the April general meeting for ZONC will be held April 5, 2020, at Claim Jumpers, 1981 Diamond Blvd., Concord, CA, 11:30 am-1:30 pm. The meeting was moved to April 5, as the second Sunday of April is Easter. The date of the May 2020 meeting is yet to be determined.
3. **Blackhawk ZONC “Meet & Greet”**- The event is scheduled for June 6, 2020, 8:00 a.m. – 12:30 p.m. Linda has coordinated the time and particulars with Blackhawk. Mary Ellen will purchase the refreshments (2-96 oz containers regular coffee, 1-96 oz container of decaf. There will be 4-5 dozen pastries). The club’s June meeting will be held after the “Meet & Greet”.
4. **ZONC Brisbane, CA, Car Show** – The car show is confirmed for August 2, 2020, 10:00 a.m. – 3:00 p.m. Linda is acting as coordinator. Jason Green motioned that 2020 show pricing (registration, t-shirts, raffle tickets) and trophy designs remain the same as 2019. Mary Ellen Rozmajzl second the motion and those attending the meeting approved. Jason volunteered to research shirts, and shirt designs including embroidery options. Linda asked everyone to work on raffle item ideas and sponsorships for the show. Linda and Bob will coordinate the search for sponsors. Linda will also get Board approval for sending in the show deposit.
5. **Rolex Monterey Motorsports Reunion (RMMR)** – It is scheduled for Aug 13-16, 2020, at Laguna Seca Raceway. Jason Green presented an e-mail from member, Ann Devor, who was unable to attend the meeting.

Hello everybody!

I spoke with Connor Barr who heads up corporate sales and partnership development for the new management at WeatherTech Raceway Laguna Seca. It is a brand new day at the racetrack and car club corrals are significantly affected. Not all of the details have been finalized yet, but here's what is going to happen.

There will be no discounts or pre-sold ticket agreements. Ticket packages will be fully offered online. A ticket package for a driver will cost \$200 and will include 3 days general admission, a parade lap and a merchandise kit. Passenger ticket packages will cost \$175. Connor is also working on a possible promo code deal where buyers will put in a special promo code and the club will get a free ticket package for every 10 promo code ticket packages sold. It sounds expensive but a break-down of this year's pricing would be \$100 for a Saturday ticket, \$75 for preferred parking and \$30 for a parade lap. Essentially a ticket package buyer gets the extra admission days for free once you get over the increases in pricing from last year.

And we (ZONC) do not pay any money up front, we do not have responsibility for picking up the tickets or mailing them out so our administrative work and costs disappear. Connor will email the ticket package details to me when finalized. He had hoped to have it up on the raceway website this Friday but it looks like it will take more time to get done. ZONC is on the car club corral list so we just wait and see what happens next. If you have any questions, please let me know and I'll do my best to get an answer... Thanks!
